To whom it may concern:

We are the surety for Engineered Hardware LLC dba TorkRite ("TorkRite"), and we confirm that they are bonded by The Guarantee Company of North America USA ("Guarantee USA"). Guarantee USA is a wholly owned affiliate of The Guarantee Co. of North America, one of Canada's largest and oldest sureties (history dating back to 1872). Guarantee USA was established to underwrite Contract Surety through its home office in Southfield, Michigan and 20 branch offices located across the United States.
